Air Capital Comic Con will be held in the Exhibition Hall of the Century 2 Convention Center in downtown Wichita, 225 W. Douglas Ave, Wichita, KS 67202.

Exhibitor parking is available at various locations around the convention center. There is both paid and free parking available. Please be sure to park legally to avoid fines. There will be a parking map provided on the website.

Tear-Down Hours: Sunday, November 14, 2021 5:00 pm – 8:00 pm

Upon arrival, check-in with event staff to obtain your exhibitor badges. No one will be allowed into the buildings during set-up and tear-down without an exhibitor / staff / or security badge. On Friday and Saturday, the Exhibition Hall and Century 2 Building will be secured overnight.

An exhibitor's application does not guarantee them entrance to participate in this event. An exhibitor's participation and placement within the event is at the discretion of the Air Capital Comic Con promoter.

Placement will be made based upon the fees received and the type of exhibitor. Special needs and/or requests must be communicated to Air Capital Comic Con staff and will be evaluated on a first come-first serve basis. Exhibitors may not assign their booth to a third party. Every request will be considered but understand it is not possible to accommodate all.

The wireless internet service is provided by the Century 2 Convention Center. The system operates much like a WiFi Hotspot, for a fee. You will need to connect to their wireless network, select the time package needed, pay with a credit/debit card, and then you will be permitted to use their internet service.

Electricity is available for a fee through power drops to each row of booths. Exhibitors are responsible for providing their own electrical cords to access power. There is a separate utilities order form provided to sign up for electricity and should be ordered two weeks prior to the event in order to avoid incurring additional fees.

Air Capital Comic Con is a family-oriented event. We support your need to buy, sell,

and trade the merchandise you commercially provide. However, during your attendance at our event no Adult-Themed Merchandise may be displayed or sold. Please take necessary precautions to ensure such items are not visible to children and your booth maintains a PG-13 rating. Your cooperation is greatly appreciated.

Air Capital Comic Con has a zero tolerance policy for harassment of any kind. Report inappropriate behavior to Air Capital Comic Con staff. Reports will be professionally investigated and an appropriate response implemented as warranted.

Rules:

Be set-up prior to and prepared for event participants during the scheduled public hours.

Recognize and adhere to all local and state laws, including those related to collection and remission of retail sales tax.

Be responsible for yourself, your personnel, and your merchandise, money and other property during the course of the event.

Conduct yourself in a safe manner at all times before, during, and after the event. Do not contribute to unsafe circumstances.

Be considerate of others and do not encroach upon the aisles and neighboring booth spaces or interfere with traffic flow and designated aisles.

Provide safely functioning electrical extension cords and power strips.

Clean-up your own messes.

Absolutely no pets are permitted to attend the Air Capital Comic Con unless they are licensed service animals.

Air Capital Comic Con supports and defends your constitutional right to bear arms. Unfortunately, in an environment such as our event, the mixing of actual firearms and prop replica / costume weapons with live action role playing creates a potential for confusion and misunderstanding; which could lead to irreversible consequences. As such, the open and concealed carry of firearms at Air Capital Comic Con is prohibited. Thank you for your understanding.

A full refund minus a 5% cancellation fee will be provided if a written cancellation notice is received sixty (60) days or more prior to the event (preferably e-mail). The date of the cancellation will be identified as the date Air Capital Comic Con receives the written notice. There will be no guarantee of refund if cancellation occurs within the sixty (60) days prior to the event. Exhibitor booth fees will not be credited toward future events. In the rare instance the event itself is cancelled, all exhibitors will receive notification by telephone and e-mail as soon as feasible, followed by a full and complete refund.
